- ✓ to provide duly trained and responsible, instrumental and economic human resources, who are useful to the pursuit of objectives of the Integrated System;
- ✓ to continuous improvement of performance, as an integral part of its activity and as a strategic commitment to the wider aims of the company;
- ✓ to comply with and enforce applicable laws, regulatory obligations and other requirements that the organisation has signed and established, which relate to the hazards to Worker Health and Safety and the Environment;
- ✓ To ensure the privacy and data protection of customers, employees and partners by taking necessary measures to ensure information security.

In terms of environment and safety, Novotema undertakes to ensure that:

- 2.1.1. - 2.1.2. Information on company risks is disseminated to all workers, their active participation is encouraged through specific forms always available to workers through periodic meetings during which proposals for improvement or reports relating to environmental and safety system- are collected;
- 2.1.3. We respond quickly, effectively and diligently to emerging environmental and safety needs during the course of work activities;
- 2.1.4. Cooperation between the different company resources and collaboration with the business organisations and the external bodies responsible is encouraged;
- 2.1.5. Company procedures, instructions, standards and, more generally, all the tools put in place to protect occupational Environment, Health and Safety are respected.
- 2.1.6. The organisation commits to reducing the environmental impact of its operations by promoting sustainable practices, reducing waste and using resources efficiently. This includes the adoption of measures to be implemented in order to limit any waste and ensure greater efficiency.
- 2.1.7. The organization is committed to mitigating climate change by promoting sustainable practices, using resources efficiently, and reducing all possible waste such as energy consumption and the environmental impact generated by its operations. This includes a series of measures to be implemented, such as the constant monitoring of consumption (energy, water, etc.), atmospheric emissions, and the containment of

greenhouse gas emissions produced by its activities, while supporting the supply chain through data processing related to the assessment of the carbon footprint.

- 2.1.8. The company is also committed to promoting the responsible use of its products throughout their entire life cycle and ensuring optimal waste management, collaborating with disposal operators to reduce the use of hazardous materials and progressively increase the amount of waste destined for recovery through the monitoring of specific indicators. Regarding hazardous products, the organization, in line with the REACH regulation, is further committed to ensuring transparency and traceability in the management of SVHC substances.
- 2.1.9. Although operating in a sector that does not directly affect natural ecosystems or the surrounding territory, the company recognizes the importance of protecting biodiversity as an integral part of environmental sustainability.

With regard to supply chain management, Novotema is committed to promoting procurement practices (purchasing of goods, services, and materials, including collaborations with suppliers, subcontractors, and strategic partners) that reduce environmental impact, support social equity, ensure economic transparency, contribute to sustainable development throughout the entire value chain, and promote human rights and decent working conditions, in particular by:

- 1. Promoting social responsibility by selecting suppliers who respect human rights, decent working conditions, and inclusion;
- 2. Promoting supplies with transparent information on the origin of materials;
- 3. Encouraging low-emission transportation and local logistics chains to reduce environmental impact, where possible;
- 4. Rejecting all forms of child labor, compulsory or forced labor throughout the whole supply chain:
- 5. Promoting safe working environments, reasonable working hours, fair wages, and respect for freedom of association, while opposing all forms of discrimination based on gender, ethnicity, age, religion, or sexual orientation.
